- **Set-up time for vendor booths is from 10:00am to 12:15pm.** Booths should be *completely set up no later than 12:30pm*. Tear down of booths may begin at 4:00 p.m. *No one will be allowed to set-up after 12:15pm for the safety of our seniors.*
- Booths will be 10' x 10'. One 8' table and 2 chairs will be provided. Vendor must provide tablecloth.
- The vendor fee is to be paid to the **Cumberland County Fair** and should accompany this Exhibit Agreement when returned to the address above.
- Electricity (110v) will be provided to booths when requested on this form. **You must bring your own industrial strength electrical cord. (Electrical cords must be taped to the floor by the respective vendor.)**
- Exhibitor shall conform to all Federal, State, City and County laws and ordinances.
- **YOU WILL ONLY BE ALLOWED TO COLLECT THE NAMES/PHONE NUMBERS OF PARTICIPANTS BY USING FORM PROVIDED BY SENIOR EXPO VENDOR CHAIRMAN. You are not allowed to sell items at your booth. THIS IS THE POLICY OF THE SENIOR EXPO at the FAIR COMMITTEE.**
- Space is limited to the first 50 vendors/booth requests.
